Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties, and civil rights.

## Assignments, Exams, and Activities

Conversations will call on you to let me know what you are learning. You will write about an interesting topic or issue in American politics after doing assigned readings. These assigned readings do not require attention to details or memorization of any information. Rather, they should be read for general awareness of the course Module themes and key concepts. I will participate and offer guidance.

The Project will call on you to contribute to developing a full and thorough knowledge of a political science article.
